

Abstract submission

Abstracts can be submitted on topics related to Clinical Psychology and/or Health Psychology to be presented as **symposium**, **oral communication** or **poster**. Abstracts will be published in "Recent Advances in Clinical and Health Psychology", which will be given to participants at the beginning of the Congress. Abstracts should be between 250 to 300 words in length and should be submitted through the conference website (section "Paper Submission") before **May 10, 2024**. They must include: type of paper, title, author(s), institution(s), complete address of the first author and e-mail. The above deadline must be strictly adhered to in order for abstracts to be accepted and published and at least one of the authors of each paper must be registered for the Congress (by **June 1, 2024**). Each author may present up to three papers. Symposia composed of 4 or 5 different papers around a central theme should be sent together, including the name of the coordinator and title of the symposium. Posters should be 90 cm. wide x 120 cm. high (or smaller).

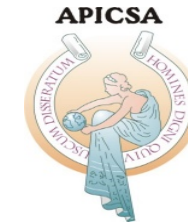
